**Question 1:** *We would like to express our interest to collaborate with NAFA in developing the Operational Assistance for Management of High Net Worth Individuals project. In order to prepare our expression of interest we would need you to provide us with more detailed information regarding the technical requirements of this project, the available budget, the Terms of Reference, etc. Can you please send us more available information on this topic?*

**Answer Q1:** Regarding your request for additional information needed for the preparation of expression of interest in order to participate in the procurement of Operational Assistance for Management of High Net Worth Individuals consultant's services, we are informing you that the only public information at this stage of the procurement procedure is contained in the published document Request for Expressions of Interest. According to the provisions of the Quality and Cost Based Selection (QCBS) procedure, at this stage, only the overall capacity of the Consultant to successfully undertake the tasks of the consultancy assignment is evaluated. Following the evaluation of received Expressions of Interest, NAFA will prepare a short list containing the best qualified Consultants and will send the necessary documents for the preparation of technical and financial offers (technical requirements, terms of reference, etc.) only to those Consultants.
