1. Romania has received financing from the International Bank for Reconstruction and Development (IBRD, the World Bank) toward the cost of the Revenue Administration Modernization Project (RAMP), and intends to apply part of the proceeds toward payments under the contract for *RAMP/I-WS Procurement of workstations, supplementary monitors and multifunction printer.*
2. The *National Agency for Fiscal Administration (NAFA)* now invites sealed bids from eligible bidders for the delivery and set-up of (1,975) *Desktop* and (780) *Laptop Workstations*, (200) *Supplementary Monitors* and (1) *Multifunction Printer* at (23) locations throughout Romania, during a period of approximately 16 weeks from Contract Effectiveness. Bidders shall have the following qualifications to bid:
 - A. *The Bidder must document having successfully completed at least two (2) contracts during the past three (3) years (2011, 2012 and 2103) involving the supply and installation of workstations including – for each contract – at least 1,000 working posts at least 5 separate sites.*
 - B. *The Bidder must provide copies of certification by an accredited institution of ISO/IEC 20000-1:2011 (or substantial equivalent service management standard).*
 - C. *The Bidder must document having ready access to at least Euro 100,000 (one hundred thousands) equivalent in liquid assets (bank balances, unencumbered securities, lines of credit etc.)*
3. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, edition of January 2011, ("Procurement Guidelines")*, and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
4. Interested eligible bidders may obtain further information from *National Agency for Fiscal Administration, Mrs. Daniela Manoli, Project Manager, ramp.anafamfinante.ro* and inspect the bidding documents during office hours *8.30 to 17.00 hours (Monday to Thursday); 8.30 to 14.30 hours (Friday) local time* at the address given below.

5. A complete set of bidding documents in *English* Language may be downloaded free of charge by interested eligible bidders from ramp.anaf.ro or can be obtained upon submission of a written or e-mail application to the address below. The documents will be sent by e-mail.

6. Bids must be delivered to the address below on or before **10.00 hours local time on November 17th, 2014**. Electronic bidding *will not* be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below at **10.15 hours local time on November 17th, 2014**.

7. All bids must be accompanied by a ***Bid-Securing Declaration***.
